Don't Pour Turkey Fryer Oil Down the Drain

eep-fried turkeys have become popular. But what about all that oil left over from frying? Your first instinct might be to pour it down the drain. Out-of-sight, out-of-mind, right? Wrong. When Fats, Oil, or Grease (FOG) is washed down the drain, it sticks around, clogging household plumbing, the sewer lateral that connects a building to the sewer main, and even the main itself. Liquefied grease and animal fat will solidify and clog pipes, much like a clog in an artery. Liquid oils coat pipes and contribute to blockages.

Blockages have caused sewers to back up into homes, resulting in messy and expensive cleanup costs and repairs. When sewer mains overflow in the street, untreated wastewater can run into parks and waterways, causing environmental damage and posing health risks. Failure to properly dispose of fats, oils, and grease is a health ordinance violation and property owners can be held responsible for the cost of cleanup and environmental damage resulting from blockage overflows.

Running hot water after the grease won't keep it from solidifying in the pipes; neither will flushing detergent down the drain after the grease or using a garbage disposal unit. The only way to keep your pipes FOG-free is never to put fats, oils, or grease down the drain.

Small amounts of fats, oils, and grease can be wiped with paper towels and, where accepted, disposed of in your green waste cart. Larger amounts of oil from deep frying should be brought to a recycling center where it is converted into livestock feed or biodiesel. Stege customers can recycle used cooking oil at the El Cerrito Recycling Center at 7501 Schmidt Lane, El Cerrito, which is next door to the Stege Sanitary District main office. Sewer Service Charge

Sewer Service Charges cover the cost of the operation, maintenance, and capital improvements to the sanitary sewer system. Stege Sanitary District collects and delivers sanitary sewer flows from its service area and delivers it to East Bay Municipal Utility District (EBMUD) for wastewater treatment. EBMUD charges a separate fee for wastewater treatment, and this is in addition to the Stege Sewer Service Charge.

Residential properties are charged a flat fee while non-residential and commercial properties are charged at a metered rate of water used. Sewer Service Charges are collected through the annual property tax bills issued by the County. A sample property tax bill is shown below. The fee shown for residential properties is an annual rate. The line item STEGE SEWER CHG are the fees assessed to your property by Stege Sanitary District.

Two Different Underground Systems



ou might think that all those manhole covers you see in the streets lead to the same system of underground pipes. They don't.

The Stege Sanitary District is responsible for the collection and transport of wastewater from homes, schools, and businesses within its boundaries to the EBMUD wastewater treatment plant in Oakland. The District's service area includes the cities of Kensington, El Cerrito and a portion of Richmond known as the Richmond Annex. These areas employ a separate storm drain system that collects rainwater runoff from the streets and surrounding grounds and deposits the water into creeks that eventually lead to San Francisco Bay.

It's important that homeowners do not pipe rainwater, either from house gutters or a sump pump, into the wastewater system. The District's sanitary system is not designed to handle the large volume of runoff from a rainstorm. Overflows of the wastewater sewers might occur if rainwater is diverted into this system. Rainwater should be directed into the street, ground, or directly to the storm drain system.

Piping rainwater into the sewer system violates District, federal, and local ordinances. Penalties and fines may be imposed for these violations.

If you see a manhole overflowing in the street immediately call the District at (510) 524-4667 and we will promptly send a maintenance team to evaluate the situation. If you have any questions about the storm runoff system, call the following numbers: City of El Cerrito (510) 215-4382 and the City of Richmond (510) 231-3011. Residents of Kensington should call their Contra Costa County office at (925) 313-7000.



Helpful Reminders



Sewer Problems? CALL US FIRST!

If you see water backing up into your home, call Stege before you call a plumber. That number is

(510) 524-4667. It is answered 24/7 by a real person. The problem may be in your lateral, or it may be in the sewer main. If necessary, we will send a crew out to investigate. The inspection is free and we try to respond within one hour.

Put Wipes in the Trash, Not in the Toilet

Unlike toilet tissue, disposable "flushable" wipes don't disintegrate in water. They retain their

form and accumulate in sewer mains where they can cause a sewer overflow into the street. Put all wipes where they belong—in the trash, not in the toilet.

Sewer Easements

Over 26% of the sanitary sewer lines in the District are located on private property in easements or reserves that were established when the lands in the area were subdivided. Property owners may NOT construct permanent structures over these easements as it restricts District access to the sewers.
